A contract of conditional sale is valid in this jurisdiction, without record, as against creditors and bona fide purchasers from the vendee. It is a matter of indifference whether the contract takes the form of a lease or the form of a conditional sale, so long as the instrument clearly shows and expressly states that the title is retained.
